8.1 Renaming of NSW Junior Championship

- 8.3 Review of policy of scrabble clubs with no members

It was agreed to introduce a \$5 player affiliation fee for any non-member playing in club that required evidence of public liability insurance

8.4 Procurement of additional boards. It was agreed that Scrabble NSW should not be in the business of importing and onselling rotating boards

- 9.1 George Khamis sugggested Thailand as a source for additional boards. He suggested that next year he will ring them in from Thailand at.\$89 each, sell for \$100 to members, \$120 for non-members. George will ask for upfront costs.
- 9.2 Confidentiality. Colleen iterated that the membership list recently sent to all members was confidential material and should not be distributed or used for any other purpose other than Scrabble .
- 9.3 Planning for NSW/ANC 2021. \$2000 grant available from national body, Burwood Club is being demolished. Suggestions for alternatives include Collaroy Convention Centre, Colleen Birch claims that access is easy. Colleen Birth will check availability for approx. 100 players.
- 9.4 Promoting Membership. Some work is being done by Bob Jackman, George Khamis, and Monica Dwyer George Khamis claims that by this time next year we will have corporate sponsorship. George also advised that he has prebooked locations for many upcoming tournaments
